About the role Role Summary

As a member of the academic staff, you will be responsible for the teaching, assessment and development of education and dance education and training modules across all Faculty of Education programmes (distance learning and onsite delivery). This position will include supervision of practical dance teaching placements in schools and colleges in private, public and community dance contexts. You will also contribute to the development of the Faculty of Education's outreach and Continuing Professional Development initiatives such as product development, and proactively engage with learning technologies to enhance learning and teaching experiences. As a Lecturer in Dance Education, you will be required to undertake administrative duties associated with module tutoring, practical teaching supervision, day- to-day management and academic and pastoral support of students. It is expected that you will contribute to the research and scholarship profile of the Faculty of Education.

- Monitoring and development of modules across all programmes in response to sector-recognised standards, educational initiatives and developments across education and dance teacher education and training;
- Supervising and tutoring student dissertations and research projects related to education, arts education, dance education, and teacher education and training at undergraduate and postgraduate levels of study;
- Working with Faculty of Education Senior Management and peer academic colleagues in the development of current and future programmes of studies;
- Engaging in learning and learning technologies to support and enhance learning and teaching experiences and outcomes.

#### Administrative Duties:

- Engagement with wider student support including pastoral care, year tutoring and academic skill development;
- Monitoring and development of learning resources;
- Supporting Faculty of Education Senior Management and Programme Managers in the annual reviews of programmes, external inspections and audits as appropriate;
